The sealed edge wipe produces a very low level of particles and fibers and is ideal for use near product contact surfaces. Hanging slot in pouch makes it easy to use in isolators.

Each pouch contains a small number of wipes eliminating any waste at the end of a session. Double or triple bagged for easy entry into the sterile suites. Validated sterile, these Low Endotoxin wipes are suitable for use in the most critical pharmaceutical cleanrooms.
